PRIVACY POLICY OVERVIEW

At <u>www.LightenUpandThrive.com</u>, we are committed to respecting your privacy and protecting your personally identifiable information. With your consent, we collect information that you provide (such as email addresses) in order to send periodic emails (newsletters, updates, etc.) and, if you sign up as an affiliate, we track click-throughs from your unique affiliate link so that if anyone purchases our services through your referrals, you will receive your commission. We make it easy for you to unsubscribe, we don't sell or share your information with third parties, to the best of our knowledge we comply with the General Data Protection Regulation (GDPR) and other regulations, and we make every effort to provide a safe, secure and pleasant experience for you.

PRIVACY DETAILS

What personal information do we collect from the people who visit our website?

When ordering or registering on our site, as appropriate, you may be asked to enter your email address or other details to help you with your experience.

When do we collect information?

We collect information from you when you place an order or subscribe to a newsletter on our site.

How do we use your information?

Do we use "cookies"?

IPs are tracked up to three months so if an order is placed, the person who referred them will receive a commission.

You can choose to have your computer warn you each time a cookie is being sent, or you can choose to turn off all cookies. You do this through your browser (like Internet Explorer) settings. Each browser is a little different, so look at your browser's Help menu to learn the correct way to modify your cookies. If you disable cookies, it won't affect the user's experience and you can still place orders.

We use a third-party provider, 1ShoppingCart, to deliver our newsletter, email updates and programs. We gather statistics around email opening and clicks using industry standard technologies to help us monitor and improve our services. COPPA (Children Online Privacy Protection Act)

- Monitor third-party email marketing services for compliance, if one is used. Honor opt-out/unsubscribe requests quickly.
- Allow users to unsubscribe by using the link at the bottom of each email.
